An organization that fails to file its return when due (including extension of time for filing) is subject to a penalty of 5% of the unpaid tax for each month or part of a month the return is late, up to a maximum of 25% of the unpaid tax. The minimum penalty for a return that is more than 60 days late is the smaller of the tax due or \$435.

Purpose of Form. Use Form 7004 to request an automatic extension of time to file certain business income tax, information, and other returns.
